All applicants must be granted a Juris Doctor from an **American Bar Association accredited law school**, and have taken a course in law school devoted to professional ethics and received a grade of "C" or better or have taken or will take the MPRE (required scaled score of 75 or higher).

1. On-line submission of the Character Questionnaire (print and retain a copy for your records)
2. This application form, signed and notarized (retain the original)
3. An Authorization and Release form, signed and notarized (retain the original)

Items 1, 2 and 3 must be uploaded – do not mail these documents. Once the Character Questionnaire is submitted, an Upload button will appear in the lower right hand corner of the User Home Page.

4. Appropriate payment (credit card, money order, certified or cashier's check ONLY; no foreign instruments). If paying by a method other than credit card, the form "**Non-credit card payments**" must be attached to the paper payment and mailed in per the instructions on the form. This form can be found on your User Home Page beneath the application form. **Fees are non-refundable. Applicants who pay via credit card do not need to submit any paper forms to the office unless specifically instructed to do so.**

Complete applications are processed in the order in which they are received. All four items above must be received for the application to be considered complete. Do not call the office to check on the status of your application. The acknowledgement packet will be posted to your User Home Page. Applicants must read the entire packet and follow the instructions contained therein.
